ORDINANCE NO. 4

RESTRICTIVE PARKING ON TOWN HIGHWAYS

THE TOWN BOARD OF THE TOWN OF PINE LAKE, ONEIDA COUNTY, WISCONSIN, FOR THE PROTECTION, SAFETY AND GENERAL WELFARE OF ITS CITIZENS AND EMERGENCY VEHICLES TRAVELING ON TOWN HIGHWAYS, DO ORDAIN AS FOLLOWS:

SECTION ONE: THIS ORDINANCE SHALL SUPERSEDE TOWN ORDINANCE NO. 4 WHICH SHALL BE REPEALED AND RECREATED AS FOLLOWS:

SECTION TWO; NO PERSON SHALL PARK, OR LEAVE UNATTENDED, ANY MOTOR VEHICLE, ON ANY TOWN ROAD BETWEEN THE HOURS OF 11:00 P.M. AND 8:00 A.M. FROM NOVEMBER FIRST (1ST) TO APRIL FIRST (1ST) IN THE SAID TOWN OF PINE LAKE.

SECTION THREE: NO PERSON SHALL PARK OR LEAVE UNATTENDED, ANY MOTOR VEHICLE AT ANY TIME ON THE FOLLOWING DESIGNATED TOWN ROADS, TO-WIT:

1. RIVER ROAD FROM COUNTY "W" TO CRYSTAL LAKE ROAD.
2. MANOR ROAD FROM RIVER ROAD TO 5223 MANOR ROAD.
3. BOZILE ROAD
4. LAKEVIEW DRIVE.
5. THE EAST SIDE OF MOEN LAKE ROAD 200 FEET NORTH AND 200 FEET SOUTH OF THE PREMISES KNOWN AS "BIRCHWOOD RUSTIC BAR" LOCATED AT 3960 MOEN LAKE ROAD.
6. FOREST LANE FROM RIVER RD. TO CREEK
7. OAK DRIVE FROM RIVER RD. TO PLAINVIEW RD

SECTION FOUR: VIOLATION OF THE PROVISION OF SECTION TWO AND SECTION THREE SHALL BE PUNISHABLE BY A FORFEITURE OF NOT LESS THAN \$35.00 NOR MORE THAN \$500.00 PLUS COSTS. FORFEITURES MAY BE PAID TO THE TOWN CLERK OR THE TOWN TREASURER.


SECTION FIVE: ANY PERSON WHO FAILS TO COMPLY HEREWITH, SHALL HAVE THEIR CAR OR VEHICLE TOWED AWAY AT OWNERS EXPENSE.

SECTION SIX: IF ANY SECTION OR PORTION OF THIS ORDINANCE IS FOR ANY REASON HELD INVALID IN ANY COURT, SUCH PORTION SHALL BE DEEMED SEPARATE AND SUCH HOLDING SHALL NOT AFFECT THE VALIDITY OF THE REMAINING PORTIONS OF THIS ORDINANCE.


SECTION SEVEN: SAID ORDINANCE IS TO TAKE EFFECT AFTER ITS PASSAGE, POSTING AND PROOF OF SAID POSTING BY PUBLICATION, WHICH SHALL BE RECORDED IN THE OFFICE OF THE TOWN CLERK.




