

SCHEDULE OF FEES AND FINES/PENALTIES TOWN OF PINE LAKE, ONEIDA COUNTY

LAND DIVISION AND CONDOMINIUM CONTROL ORDINANCE #07-01

Fees –

\$100.00 for two lot land division/subdivision

\$25.00 per lot over two lots

Penalty

Cash deposits for violation of any part of the Pine Lake Land Division and Subdivision Control Ordinance shall be \$500.00 and in addition shall include any and all court costs, assessments and penalty assessments as permitted by Section 165.87 Wis. Stats. including a 23% penalty assessment, a \$5.00 justice information fee, a \$40.00 court support fee, \$20.00 court costs, \$5.00 circuit court automation project fee and \$10.00 jail assessment fee.

4. Whenever any violation has occurred, the town attorney shall prosecute as provided by law.

5. In addition to the forfeiture described above, the owner of property who divides the property without compliance with this Ordinance and without town approval shall be subject to paying all costs necessary to rectify the infraction.

DRIVEWAY/PRIVATE ACCESS ROAD PERMIT ORDINANCE

Fees –\$150.00 per driveway off town road.

Easement roads into subdivisions require driveway permit

BUILDING PERMITS

New Home Construction UDC permits through Rhinelander Building Inspector – costs set by that office

Building Permits are acquired through Oneida County Planning & Zoning – costs set by that office

UNLICENSED VEHICLES ORDINANCE #6 TO CONTROL THE PLACEMENT OF UNLICENSED MOTOR VEHICLES, AUTOMOBILES, TRUCKS AND RECREATIONAL VEHICLES

Fees –

Permit \$50.00 per year – renewed annually

Penalty-

Not to exceed \$100 plus court costs (default could result in jail time of 10 days)

RESTRICTIVE PARKING ON TOWN HIGHWAYS ORDINANCE #4

Penalty – Not less than \$35 nor more than \$500 plus costs

FIREARMS AND FIREWORKS ORDINANCE #06-04 REGULATING USE OF FIREARMS, OTHER WEAPONS AND FIREWORKS

Fees –

Fireworks Permits \$50 plus proof of insurance or insurance bond per ordinance

Penalty –

Violation \$200

DOG RESTRICTIONS AND LICENSING ORDINANCE

Dogs License annual - \$5.00 for neutered/spayed dogs and \$15.00 intact dogs

Application on town website – contact town treasurer with questions

WASTE MANAGEMENT AND RECYCLING ORDINANCE #08-02

Penalty –

Not less than \$25 for second offense, \$100 for third and subsequent offenses

SNOW ONTO ROADS ORDINANCE #96-1

Penalty –

\$50 with cost of prosecution

BOATING REGULATION ORDINANCE #06-01

Penalty –

WI State Boating Penalties found in WI Stat 30.80 and deposits established in Uniform Deposit and Bail Schedule established by WI Judicial Conference

SNOWMOBILE ACCESS ORDINANCE #08-01

Penalty –

WI State snowmobile penalties as found in s.350.11(1)(a) WI Stats

Fees – Actual cost of copying records .25/page

Actual cost of locating records if the cost

Is more than \$50 - \$20/hour after first 1 ½ hours to locate

Actual cost of shipping/handling

UTILITY APPLICATION/PERMIT TO CONSTRUCT, MAINTAIN, AND OPERATE UTILITES OR FOR PLACING OF OBSTRUCTIONS WITHIN TOWN ROAD RIGHT-OF-WAYS (8/19/2015)

Permit Fee - \$200.00 per year

Non-Compliance Fee/Fine shall be assessed if restoration to original grade and slope with seeding is not met within 2 weeks of project completion - \$100

Penalty up to \$50.00
